

Residency period: Junior docs go on strike, minister warns of action

MEMBERS Of the Junior Doctors' Association (JDA) of BJ Medical College (BJMC), affiliated with Ahmedabad Civil Hospital, Wednesday went on strike from routine OPD and operation theatre duties over long-pending demands of equating the bond period with the senior residency duration owing to their service in Covid-19 wards for nearly 17 months.

A JDA office-bearer told this paper, "Of the 36 months of course-work as a post-graduate course candidate, we served nearly 16-17 months in Covid wards, which also affected our academics as we were not dealing with regular OPDs. The state government considered equating the senior residency period with the mandatory bond period

for those admitted in 2017 and 2018 but has not considered the same for those admitted in 2019, despite the Covid work that was done by the 2019 batch as well."

Meanwhile, state Health Minister Rushikesh Patel told media persons on the sidelines of an event in Patan: "If the strike continues, the state has its recourse and will take disciplinary action if required. It is my request that they rejoin duty."

BJMC JDA has been raising the issue since last year, and had in February this year made written representations to the chief minister's office as well as to the health minister. In March, the health minister wrote to the additional chief secretary of the health department advising them to "take appropriate actions" with respect to the request put forth by JDA. BJMC post-graduate course director and medical superintendent of Ahmedabad

Civil Hospital, on May 28 and June 6 respectively, wrote to the additional chief secretary endorsing and recommending for counting bond service equal to the residency period.

Residency is a year-long specialised training after three years of the post-graduate programme and becomes mandatory if one wants to apply for teaching positions. In Gujarat, for those admitted through state quota seats, students are also mandated to serve a year-long medical bond period as rural tenure, which is separate from the residency period.

BJMC JDA plans to boycott Covid and emergency services on June 16 as well "if there is no positive response from the government". A similar strike was held last year, following which, the state government agreed to consider one year of residency equivalent to one year of bond service.

GPCB, Pandesara Infra join hands to grow trees in GIDC area

Surat: The Gujarat Pollution Control Board (GPCB) and Pandesara Infrastructure, a subsidiary of the Common Effluent treatment plant of Pandesara, have signed a memorandum of understanding (MoU) to increase the green cover in the GIDC area in Pandesara, Surat.

As a pilot project, over 300 plants were planted in a 500-square metre plot, while works in progress to make a green cover on three open unused plots in the GIDC area.

GPCB regional officer in Surat, Jignaben Oza, said, "We have identified three more plots where we plan to grow around 11,000 saplings... In the next five years, they will grow into big trees and provide more green cover. The plants are selected to maintain oxygen levels in nature." **ENS**

FILED DURING 2015 AGITATION Patidars reiterate demand on withdrawal of cases

THE PRESIDENTS of 18 major Kadvia and Leuva Patidar organisations that met at Vishv Umiyadham's Jaspur campus in Ahmedabad on Wednesday reiterated their long-pending demand to withdraw pending police cases registered during the reservation agitation in 2015.

The Co-ordination Committee of Patidar Organisations also demanded that the government provide immediate employment to the families of the youth who were "martyred" during the agitation. The presidents held discussions on issues affecting 25 non-reserved classes (Savarna Samaj) and decided to make appropriate representations to the government regarding the same.

They also deliberated on injustice to non-reserved categories in the recent recruitment of PSI, making consent of parents in marriage registration compulsory for women marrying against their parents' consent and the failure of state government to fill vacant posts of chairman of non-reserved commission and corporation.

Veljibhai Sheta, president, Samast Patidar Samaj, Surat, said that parents should be compelled to be witnesses in the registration of marriages by young women without the consent of the family. "The government should give due consideration and make appropriate changes in the marriage rules," he stated.

RP Patel, president of Vishv Umiya Foundation in Ahmedabad and convener of the Co-ordination Committee of Patidar Organisations, said that the meeting was entirely on social issues faced by the community and no political issue was discussed.
